2. Objects of the trust shall be -

Main objects -

2. To run and / or manage school / technical education centres / trainingcentre for educating the boys and girls and to develop character of the students as well as educate them in physical culture.
3. To run and / or maintain boarding house of the students. For meeting the above main objects the trust will do all acts in regards -
 - A. To open, found, establish, promote, maintain, run, and / or manage Delhi public School RAJDHANWAR under (S.R Educational trust, for the students both boys and girls for proving genera education right from Nursery up to

- B. To open, found, establish, promote, maintain, run and / or manage technical education centres for the students both boys and girls for their technical education.
- C. To obtain permission, license, certificate and / or authority for running and / or managing education centres like school / technical education centres.
- D. To assist, finance and / or help in setting up / maintaining / managing / running educational institution including technical and / or vocational and to affiliation thereof from recognized board and / or appropriate authority.
- E. To open, found, establish, promote, maintain, assist, finance and / or help in setting up / maintain / running any hostel, laboratory, library, reading rooms, auditorium and / or playground for the students.
- F. To open, found, establish, promote, maintain, assist, finance and / or help in setting up / maintain / running any hospital, charitable dispensaries, maternity homes, diagnostic centre, health check up centres etc for welfare of the society.
- G. To provide all round assistance to the needy person including children, women and old men.
- H. To promote assist and / or maintain such, other social or cultural activities as may be necessary for achieving the objects of the trust and conducive to the wellbeing and general welfare of the people.
- I. Whereas it is further declared that the trustee with consent of the settler, subject to the condition that any such addition shall be confined solely to the purposes to the welfare of the public at large.

The trustee will have discretion to decide on financing, patronizing or assisting any one of some or all such objectives and proposes as they alone, in their absolute and unconditional discretion, would deem fit and proper or on the priorities as they,

- a. That both the trustees shall be the permanent trustees, having rights of succession i.e., in case of death of any permanent trustee his heir will succeed him as per family agreement, failing which the elder son / daughter will join permanent trustee.

g. That after seizure of the rights of nominated as trustee, any / or of them may be re-nematode as trustee for the further term.

h. that permanent Trustee shall be in charge of the day to day affairs of the trust.

i. That in case any financial assistance is required for proper management of the trust and to meet the objects of the trust finance may we taken from any government / non government / semi government / financial institution / nationalized bank/ post office / other financial of trustees/ individuals. Trust property may be mortgaged or obtaining any loan from any organisation/ Bank/ financial institutions/ individual, after approval of the board of trustees.
